**Explanation of Responses:**

1. 9,240 of these Common Shares were issued as restricted stock and remain invested under the terms of the Vornado Realty Trust 2002 Omnibus Share plan (the "Plan"), with each original grant vesting in equal portions over a five year period. Of these 9,240 Common Shares, (i) 4,620 Common Shares of restricted stock remain to vest in January of 2009, (ii) 4,620 Common Shares of restricted stock remain to vest ratably in January of 2009 and 2010.
