AMENDMENT NO. 6 TO SCHEDULE 13D  
RELATING TO THE COMMON SHARES OF BENEFICIAL INTEREST OF  
PRIME GROUP REALTY TRUST

Vornado Realty Trust ("Vornado"), Vornado Realty L.P. (the "Operating Partnership") and Vornado PS, L.L.C. ("Vornado PS" and, collectively with Vornado and the Operating Partnership, the "Reporting Persons") hereby amend their Statement on Schedule 13D filed with respect to the Common Shares of Beneficial Interest, par value \$0.01 per share ("Common Shares"), of Prime Group Realty Trust, a Maryland real estate investment trust (the "Issuer"). This Amendment No. 6 to Schedule 13D ("Amendment No. 6") should be read in conjunction with the Statement on Schedule 13D of the Reporting Persons filed on November 2, 2001 (the "Initial Schedule 13D"), as amended by Amendment No. 1 to Schedule 13D of the Reporting Persons filed on November 20, 2001, by Amendment No. 2 to Schedule 13D of the Reporting Persons filed on December 19, 2001, by Amendment No. 3 to Schedule 13D of the Reporting Persons filed on December 21, 2001, by Amendment No. 4 to Schedule 13D of the Reporting Persons filed on December 27, 2001 and by Amendment No. 5 to Schedule 13D of the Reporting Persons filed on January 15, 2002 (as so amended, the "Schedule 13D"). This Amendment No. 6 amends the Schedule 13D only with respect to the items listed below. Unless otherwise indicated, all capitalized terms used but not defined herein shall have the meaning ascribed to them in the Initial Schedule 13D.

Pursuant to Rule 13d-4 under the Exchange Act, each of the Reporting Persons declares that the filing of this statement shall not be construed as an admission that such Reporting Person is, for the purposes of Section 13(d) or 13(g) of the Exchange Act, the beneficial owner of any Common Shares.

Any disclosures made herein with respect to persons other than the Reporting Persons are made on information and belief after making appropriate inquiry.

Item 4. Purpose of the Transaction.

Item 4 is hereby amended by adding the following two paragraphs at the end thereof:

On January 29, 2002, the United States District Court for the District of Delaware affirmed the Bankruptcy Court's dismissal of the Borrower's bankruptcy petition and denied the Borrower's appeal to the District Court.

On January 29, 2002, Vornado PS and the Operating Partnership filed a complaint against Michael W. Reschke in the Supreme Court of the State of New York, County of New York seeking (i) specific performance of Mr. Reschke's agreement to resign from all his positions as trustee, director or officer of the Issuer and its affiliates in the event of a bankruptcy of the Borrower, (ii) award of damages to Vornado PS for costs, losses, damages and expenses incurred as a result of the Borrower's filing of a bankruptcy petition and its and Mr. Reschke's efforts to obstruct Vornado PS's rights under the Subordinated Loan and the Senior Loan and (iii) a declaration of Mr. Reschke's obligations to pay such costs, losses, damages and expenses that are incurred in the future.

Item 5. Interest in Securities of the Issuer.

Item 5 is hereby amended by adding the following sentence at the end of paragraph (c) thereof:

No transactions in the Common Shares were effected by Reporting Persons since January 15, 2002, except to the extent that such transactions may be deemed to have occurred as described in Item 4.
