

Vornado Announces Certain Items to be Included in its Third Quarter 2018 Financial Results

NEW YORK, Oct. 10, 2018 (GLOBE NEWSWIRE) -- Vornado Realty Trust (NYSE: VNO) today announced that its financial results for the quarter ended September 30, 2018 will include the items listed below, which will result in additional net income of \$0.65 per diluted share and will be included in Vornado's third quarter 2018 "net income attributable to common shareholders" and will be excluded from "net income attributable to common shareholders, as adjusted." These items will decrease our FFO attributable to common shareholders plus assumed conversions in the third quarter 2018 by \$0.02 per diluted share and will be excluded from "FFO attributable to common shareholders plus assumed conversions, as adjusted."

- a \$134.0 million net gain (not included in FFO) resulting from the previously announced sale of our 49.5% interest in the 666 Fifth Avenue Office Condominium;
- \$7.3 million of net income and FFO from the repayment of the 666 Fifth Avenue Office Condominium mortgage loan;
- \$8.0 million of net loss and negative FFO related to the change in fair value of marketable securities;
- \$0.6 million of net loss (\$2.7 million of negative FFO) from other items.

The above amounts are preliminary estimates. There can be no assurance that Vornado's final results will not differ from these preliminary estimates as a result of quarter-end closing procedures, review procedures, or review adjustments, and any such changes could be material.

FFO is computed in accordance with the definition adopted by the Board of Governors of the National Association of Real Estate Investment Trusts ("NAREIT"). NAREIT defines FFO as GAAP net income or loss adjusted to exclude net gains from sales of depreciated real estate assets, real estate impairment losses, depreciation and amortization expense from real estate assets and other specified non-cash items, including the pro rata share of such adjustments of unconsolidated subsidiaries. FFO and FFO per diluted share are non-GAAP financial measures used by management, investors and analysts to facilitate meaningful comparisons of operating performance between periods and among our peers because it excludes the effect of real estate depreciation and amortization and net

gains on sales, which are based on historical costs and implicitly assume that the value of real estate diminishes predictably over time, rather than fluctuating based on existing market conditions. FFO does not represent cash generated from operating activities and is not necessarily indicative of cash available to fund cash requirements and should not be considered as an alternative to net income as a performance measure or cash flow as a liquidity measure. FFO may not be comparable to similarly titled measures employed by other companies. In addition to FFO, we also disclose FFO, as adjusted. Although this non-GAAP measure clearly differs from NAREIT's definition of FFO, we believe it provides a meaningful presentation of operating performance.
