

Vornado Announces Details Of Its Common Share Dividend Payable on March 12, 2009

PARAMUS, N.J.--(BUSINESS WIRE)-- VORNADO REALTY TRUST (NYSE:VNO) announced today that its \$0.95 common share dividend, payable on March 12, 2009 will consist of approximately \$59 million in cash and approximately 2.8 million common shares priced at \$32.0741 per share, as follows:

- Holders of 11.3 million shares elected to receive the dividend all in shares;
- Holders of 122.0 million shares elected to receive the dividend all in cash, and will receive \$.415 per share in cash (43.7%) and \$.535 per share in stock (56.3%);
- Holders of 22.1 million shares made no election, and will receive \$.38 per share in cash (40%) and \$.57 per share in stock (60%).

Vornado Realty Trust is a fully-integrated equity real estate investment trust.
