The Reporting Person has no right to take possession of the underlying security.
- The Phantom Units become payable in cash to the Reporting Person commencing upon a distribution at a future date from the Vornado Realty Trust Nonqualified Deferred Compensation Plan.
- Represents weighted average purchase price. These Preferred Shares were purchased in two transactions through the execution of a single market order at prices of \$53.545 and \$53.554.
